MACHINERY DIRECTIVE 2006/42/EC

The Machinery Directive defines the tasks for meeting essential health and safety requirements of general application, supplemented by a number of more specific requirements for certain categories of machinery, with the intention of removing trade barriers within Europe and ensuring users and operators a high level of safety and health protection.

In 1989 the Council of the European Union published the directive on the approximation of the laws of the member states relating to machinery, known as the Machinery Directive (89/392/EEC). This directive had to be implemented in all member states of the EC by 1995.

In 1998 various amendments were combined and consolidated into the Machinery Directive 98/37/EC. In 2006 a "New Machinery Directive" (2006/42/EC) was published, replaced the previous version and came into full effect from 29 December 2009.

Manufacturers before placing their machines on the EU market, should confirm the conformance of their machines to all requirements of the Machinery Directive, as well as prepare a declaration of conformity and a technical file.
